

She explained that the women Empowerment is the vital instrument to expand women stability to resources and to make strategic life choices. Empowerment of women is essentially the process of upliftment of economic, social and political status of women, the traditionally under privileged once, in the society. It is the process of guarding them against all forms of violence. She further said that women

population is around 50% of the total population of the World and now a day women are increasingly gaining control over their lives and are actively taking their own decisions with regard to their education, career, profession and lifestyle. She has stated that women have demanded equality with men in matters of education, employment, inheritance, marriage and politics. Further she explained that women empowerment implies the ability in women to take decisions with regard to their lives and work and giving with equal rights to them in all spheres like personal, social, economic, political, legal and so on. They are playing multiple roles – at home as a mother, daughter, sister and wife and at working place as professional with remarkable simplicity and compatibility. It is not true that women, to a large extent, do not face, discrimination in the society today, unfortunately many of them face exploitation and harassment which can be diverse types - emotional, physical, mental and sexual and they are often subjected to rape, abuse and other forms of physical and intellectual violence. While explaining as above, She stated that the Parliament of India has passed various legislations to save women from various forms of injustice and discrimination.
